439th Meeting held on 22 June 2015

Remarks

This being her final meeting, the Chair of the Board acknowledged the tremendous collegiality and expertise of the governors serving on the Board, counting her time at York among her most rewarding experiences. Noting the University's achievements in recent years, she extended warm thanks and appreciation for the support received from the senior administration and their staff, and particularly President Shoukri. Mrs Foster emphasized York's good fortune to have Rick Waugh as its succeeding Board Chair.

Appreciation was conveyed to retiring governors for their hard work and dedication during their terms, and newly appointed members of the Board were welcomed.

- changes to the meal plan rates and policies for 2015/16 as follows:
 - restructuring of the meal plan account and policies to provide for a single, non-refundable Meal Plan account with carry forward balances permitted with a \$50 administrative fee
 - o a 5% increase to the rates for all meal plans
 - o an increase to the portion of non-refundable taxable funds within each meal plan (*Refer to the Board agenda for the revised fund levels for each plan*)
 - a \$50 programming fee incorporated in each meal plan (\$25 for the optional suite plan)
- an extension of the York Lanes Ground Lease to YUDC from 40 years to 65 years, and authorization for the Vice-President Finance & Administration to finalize the lease terms and execute the lease extension.
