Report of the Academic Colleague to the Council of Ontario Universities April 2017

The meeting of the Council of Ontario Universities of April 5-6, 2017 discussed progress concerning many predictable ongoing issues including: The Funding Review and Strategic Mandate Agreements, OSAP Transformation, Experiental Education and A Highly Skilled Workforce, Student Data (re anti-racism strategy), a Strategic Engagement Campaign Update, and a report from Universities Canada.

A majority of the time was devoted to Indigenization Initiatives at Ontario Universities, with particular attention to how faculty members are engaged in campus indigenization efforts, and what opportunities or supports will assist them in strengthening indigenization efforts on their campuses. Discussions among Academic Colleagues and in the full Council were aided by three experts – indigenous faculty members from three Ontario universities. It is hard to distill several hours of discussion into a one-pager, but the following are my personal observations of major points that emerged:

- As good academics, we repeatedly questioned whether "indigenization" was even the right term to use, with alternatives like self-determination, empowerment, transformation and "extending the rafters" being suggested.
- Every university is engaged in indigenization efforts, including but not limited to responses to the recommendations of the Truth and Reconciliation Commission. There is no one way to "do indigenization", given the diversity of universities, and of indigenous communities.
- Common prominent themes include the development of an indigenous strategic plan, increased hiring of indigenous faculty, admission and support for indigenous students, and incorporation of indigenous knowledge into the curriculum.
- Many universities, like York, have taken up the practice of land acknowledgement. Among indigenous peoples acknowledgement of the land is deeply meaningful, as visitors consider the land and the stories that have unfolded there. We should be sensitive to the deeper meaning of our acknowledgements, and not allow them to become perfunctory or mechanical.
- Indigenous faculty are needed to teach indigenous content, but do not belong only in Indigenous Studies programs. There was uncertainty about whether, and the extent to which, indigenous content can be taught by non-indigenous faculty.
- Some well-intentioned non-indigenous faculty are unsure, and even afraid, about what to do or say, for fear of doing something wrong. Cultural competency training is an important ongoing need.
- Successful indigenization, like the associated concept of reconciliation, is not amenable to a quick fix. There must be a long-term commitment and sustainable effort.
- The criteria of success include the following principles:
 - o Meaningful engagement of both communities
 - o Mutual benefit
 - Concrete actions that transfer leadership


Nine York students were among the 338 young women to attend Equal Voice Canada's historic Daughters of the Vote initiative in the House of Commons on International Women's Day.

The Executive Committee met on April 18 and makes this report to Senate for information.

Section B, 3 (Periodic Review and Publication of Senate Membership Reviews) stipulates that "Senate Executive shall review changes in structures, faculty complements and student enrolments every two years..." The Committee embarked on the process of review in anticipation of presenting recommendations to Senate in February. Changes in membership are statutory in nature and involve notice of motion at the first stage of revisions.

The allocation of seats for full-time faculty members elected by Councils is determined by first calculating the proportion of the overall complement attributable to each Faculty (tenure stream, alternate stream and CLAs) based on the most recently available data. Percentages are then applied to the full-time faculty member seats on Senate.

Minor adjustments are necessary because of the following considerations:

- it has been a long-standing rule that no Faculty shall have fewer than four faculty member seats, and two Faculties (Education and Environmental Studies) receive additional seats according to this stipulation
- since 2013, Glendon has been allocated two more seats than a strictly proportional formula yields by virtue of its special nature (an allocation confirmed by Senate in 2015)

The Committee does not recommend any changes in student membership. The relatively large size of the student population in Liberal Arts and Professional Studies continues to justify the allocation of four seats more than other Faculties.

Notice of this motion was given at the March 23, 2017 meeting of Senate. There was no discussion of the recommendation at that meeting.

2. Additions to the Pool of Prospective Honorary Degree Recipients

In a confidential report from the Sub-Committee, the Senate Executive received recommendations to add individuals to the pool of prospective recipients of honorary

degrees. The Committee concurred with all of the recommendations and, as a result, five new candidates have been deemed eligible for honorary degrees.

3. Draft Amendments to the Senate Policy on Accommodations for Students with Disabilities

The Sub-Committee on Equity has prepared draft amendments to the *Senate Policy on Accommodations for Students with Disabilities* and is now in the process of consulting within the community. Senate Executive provided feedback to the Sub-Committee at its meeting of April 18. This is an important initiative that addresses our commitment to access and student success, UAP goals and public policy. Senators are urged to contribute to the consultations, which will include engagement with Faculty Councils.

4. Senator and Senate Committee Survey

The annual surveys of Senators and Senate committee members began two months earlier than usual in order to maximize participation and to increase the value of responses to the University Secretariat and Senate Executive. As of April 21 a total of 55 Senators and 37 committee members had provided input through the surveys. Both totals are up from last year but still below peak levels. The Executive Committee urges all Senators to take part in the survey. An email reminder with a link to the survey will be issued after the April 27 meeting.

5. Congratulations to Professor Lisa Philipps

Members congratulate Professor Philipps, the member of Senate Executive from Osgoode, on her appointment as Interim Provost. We look forward to working with Lisa in her new capacity.

Consent Agenda

1. Transfer Credits from the Sampradaya Dance Academy for the BFA Program in Dance • School of the Arts, Media, Performance and Design

ASCP recommends that approval be given to grant a maximum of 54 block transfer credits to eligible graduates of the Sampradaya Dance Academy Professional Training Program towards the Honours BFA or BA Programs in Dance within the School of the Arts, Media, Performance & Design.

Rationale

The Senate Transfer Credit Policy enables granting transfer credit from accredited and approved post-secondary institutions towards degrees at York. The legislation also allows for transfer credit from non-accredited institutions to be awarded on a case by case basis.

The School of the Arts, Media, Performance and Design and ASCP is proposing that York recognize the courses of the Sampradaya Dance Academy Professional Training Program for credit at York. AMPD has long established partnerships with professional training schools. It offers a Teacher Training Program in conjunction with the National Ballet School (NBS) whereby students combine study toward their Honours BFA in Dance with the Ballet School to earn both a degree from York and a Diploma from NBS. Similarly, graduates of the three-year Professional Training Program at the Toronto School of Dance Theatre are eligible to receive 60 transfer credits towards and advanced placement in an Honours BFA degree at York. The proposed transfer credit arrangement with the Sampradaya Dance Academy is a comparable initiative.

Extensive consultation has taken place between the Department of Dance and the Sampradaya Dance Academy over the last seven years. There are strong ties and philosophical similarities shared by the two programs, with faculty members from both institutions having professional relationships as teachers, choreographers and performers.

Professional dance students are looking to transfer to university programs. The proposed formal pathway between Sampradaya and York would allow academically motivated students the opportunity to complete their professional training and then transfer to York's academic program. It is expected that two students per year would apply for admission and transfer credit.

Academic Standards, Curriculum and Pedagogy Committee Report to Senate

A detailed analysis of the studio courses from Sampradaya and the York Dance courses has been undertaken and an outline of the required courses Sampradaya graduates would need to complete for the BFA Dance degree has been established. This detail would be included in a Transfer Articulation Agreement between Sampradaya and York University upon Senate approval of the transfer credit proposal.

2. Fall Reading Week

ASCP has approved in principle revisions to the Senate Policy on Sessional Dates and the Scheduling of Examinations to re-introduce a Fall Reading Week held over the four days following Thanksgiving in October. The proposal to return to a four day Fall Reading Week emanated from the York Federation of Students. It highlighted the growing need for the University to take students' mental health into account in academic planning decisions, and proposed that an extended break in the Fall term is a step toward that end.

As Senators will recall, the Sessional Dates policy sets out guidelines to govern the determination of dates for each of the Fall and Winter terms. Those guidelines articulate the key considerations to be taken into account in setting the dates, such as scheduling a 12 week teaching term, a formal examination period and a minimum one day study break before exams begin. Setting the term dates and accommodating the growing list of considerations for the already constricted Fall term has become a complicated matter.

The proposal to schedule a four-day Reading Week in October requires doubling the Policy's current allotment of two break days (in late October-early November) which, in turn, requires the two days to be freed up from existing allotments. Discussions with the Office of the Vice-Provost Students on this proposal revealed that there is flexibility on the timing of academic orientation, such that holding events prior to Labour Day may be an option, particularly as this is a direction other universities are moving towards.

ASCP has indicated its support for moving to a 4-day Reading Week after Thanksgiving and holding orientation prior to Labour Day. The change in timing for orientation carries logistical changes in administrative arrangements at the University, such as students' earlier access to residence. Consultation with the necessary departments on the arrangements is in process. The committee's approval of the revisions to the Senate Sessional Dates policy therefore, is contingent on the University being able to accommodate the logistical changes. With the conditions met, a full proposal and rationale will proceed to Senate for approval.

3. New Curriculum Management System

At a recent meeting the University Registrar, Carol Altilia, briefed the committee on the University's new curriculum management tool currently being implemented. The system is a software tool that will support the workflow of the curriculum development and approval process, serve as a curriculum repository and enable the effective management of programs' curriculum, publish the academic calendars and integrate with student records. Its design and capacity will significantly enhance the curriculum review process and provide support for the UAP priorities of enhancing quality academic programs and quality academic advising. The Lassonde School of Engineering is participating in the first phase of implementation, with July as the target completion date for its testing. The roll-out to other Faculties will follow in a coordinated schedule over the next two years.

1. Report on New Awards for Calendar Year 2016

Attached as Appendix A is the list of new awards approved during the 2016 calendar year, prepared by Student Financial Services (SFS). SFS approves the awards according to Senate-approved guidelines and reports annually to Senate through the Senate Committee on Awards. Statistical data and report highlights are provided below, with comparative data for 2015 and 2014.

- Overall, the number of new awards remained relatively constant, with a slight increase of 11 awards on a year over year basis.
- The decline in endowed awards following the cancellation of the government matching program in 2014 is starting to reverse. The minimum endowment is \$25,000 and most awards are established at the minimum level. FGS fellowships are funded from the operating budget.
- Most awards are in the \$1,000-2,000 range; however, the number of awards in the \$500-\$1,000 range continues to increase. This is directly attributed to the increase in new endowed awards. Because of a change in the way the University deals with the endowments, the values for these awards have conservatively been set at a minimum of \$1,000 given that the available funds can be impacted by investment income performance. If there are more than the minimum funds available they will be distributed.
- The amount often varies for bursaries as they are needs-based, and for prizes where it is split based on the number of members on a team.
- There has been a recent increase in the number of awards in memoriam, with the downside that they are often restricted to particular Faculties or programs.

The increase in Faculty of Graduate Studies awards to some extent reflects the establishment of three new prizes within the Graduate Program in Education, the creation of two new graduate awards by the Department of Mechanical Engineering in

the Lassonde School of Engineering and the establishment of six new award codes to facilitate the disbursement of funding to graduate students under the graduate fellowship packages. It should be noted that all of these new awards are being funded through University's Operating funds.

Almost all of the increase of nine new Faculty of Liberal Arts and Professional Studies awards are from new donor agreements. In addition, the Faculty designated funds from general endowments to create a new award for top international applicants admitted into the York World Scholars program and also created a fund to provide financial support to sole support parents to offset daycare costs.

Most of the increase in the number of new Schulich School of Business awards is the result of new donor agreements (some in honour of the 50th anniversary of the school); the faculty itself also established 6 new awards including two new codes created to facilitate the disbursement of funding to graduate students under the graduate fellowship packages.

Osgoode Hall Law School saw significant decreases in new awards, for the most part because many awards created in 2014 -15 came from a campaign tied to the 125th anniversary of Osgoode in 2014.

Table 2 lists awards by funding types. There was a significant increase in the number of new awards funded by operating funds, the bulk of which are graduate awards. This increase can be partially attributed to the creation of 8 new award codes directly linked to the fellowships packages. There were also a variety of prizes and awards created across the faculties to recognize research and teaching excellence. In addition, there

was an increase of 8 undergraduate awards established from operating funds, including the Provost's Award (entrance award for College and University transfer students) and funds allocated to provide support to refugee students.

Table 4 summarizes the types of awards offered. A description of the funding types is attached as Appendix B.

The Award category (selection based on a combination of academic merit *and* financial need) continues to be the most common classification. The decline in the number of new scholarships reflects the 2014 creation of new scholarships under the Enhanced Entrance Scholarship Program. The Loan category, new in 2015, has one award which is the new Osgoode Income Contingent Loan program being piloted over the next five years. It will provide students with tuition loans which would not need to be repaid until after graduation. Recipients have 10 years to repay their loans and can apply for loan forgiveness on the basis of their income level in each year of the repayment period.

The majority of awards approved continue to be In-Course awards, which are adjudicated in the Fall/Winter study period.

Looking to the future

York University launched its "This is Impact" campaign in April 2016. One of the themes of this \$500 million fundraising campaign includes a goal to raise \$140 million to "provide learning experiences and the financial support that students need to become the global leaders of tomorrow". It is hoped that this will translate into significant additional funding for scholarships and awards so that we can continue to attract and retain top students and provide them with the financial support they need to complete their studies with little or no student debt.

2. Report on Graduate Awards Disbursement for 2014-2015

The Senate Committee on Awards receives annually from the Faculty of Graduate Studies (FGS) a report on the disbursement of student awards for the previous academic year. The committee received a report from the Faculty of Graduate Studies on graduate awards disbursement for 2014-15, with comparative data for the previous six years. All data is from the York University Factbook.

Michael Zryd, Associate Dean, Academic Affairs, presented the report, noting the following:

- A decrease in success with NSERC funding (but there has been improvement which will be reflected in the 2016-17 report).
- CGS-M funding is determined by all research grant income generated by students and faculty making it very important that faculty continue to apply for grants. This will be recalculated every two years instead of the previous every three years. It is hoped that PhD success will translate into a future bump in numbers.
- The decline in the number of CGS-M SSHRC grants is a reflection of the decline in faculty SSHRC success.
- In the past have had good success with the mega awards Vanier, Trudeau, Banting. This year York received only one Banting but the number of applications across the country has increased significantly in the last couple of years.
- York received three Trudeau awards out of fifteen nationally, which increased the University's profile in relation to this prestigious award.
- The value of the external awards varies from \$17,500 to \$60,000 for the Trudeau; the average is around \$20,000.

External Award Trends: 2009-10 to 2015-16



General Overview

Overall, the number and value of external awards held by York University graduate students remain very close to 2014-15. In 2015-16, the total value of the external awards increased by 1.5% while the total number of students who held an external award saw a small decrease. As the data by agency illustrate in the subsequent sections below, trends are not consistent across agencies, and the slight decline is largely attributable to the decrease in the success rate of NSERC doctoral awards (the previous year the decline was due to lower SSHRC numbers).




Awards by Agency

CIHR:

Both the number and value of awards paid out by the Canadian Institutes for Health Research (CIHR) have increased in 2015-16. As CIHR applications at the doctoral level are not restricted by a quota, the number of applications for doctoral awards forwarded to CIHR vary from year to year, which is a factor that explains the variances in the funding levels over the years. Since there is no limit to the number of CIHR doctoral applications we may submit, developing competitive applications is the key to improving the success rate in future CIHR doctoral competitions.






NSERC:

The level of and trends in NSERC graduate student funding continue to be a concern. The university's level of NSERC graduate student funding has fallen significantly since 2009-2010. As NSERC award applications for both doctoral and Master's levels are restricted by a quota which is determined by past successes, weak performance in one year tends to be compounded in future years. For example, York's quota for the number of NSERC doctoral applications that may be forwarded to the national level of adjudication was limited to 11 for the 2017-18 competition (which took place in the fall of 2016). However, the good news is that, due to growing NSERC stream students at York, the quota at the CGS-Master's awards have increased from 6 to 11. FGS continues to receive steady numbers of applications, and enhancing the support for the development of competitive applications is essential in improving the success rate in NSERC competitions in the long run.






SSHRC:

There was a decline in SSHRC awards funding in 2014-15, and the total value of awards was the second lowest since 2008. In 2015-2016, in terms of value, we are back at previous levels, but the number of awards has not changed significantly. However, SSHRC awards held by York graduate students continue to outnumber those offered by the two other agencies, with the total value approximately ten times more than that of CIHR and NSERC, respectively.

Internal Award Trends: 2009-10 to 2015-16

The total value of the internal awards offered to graduate students has gone up in 2015-2016. The three years before this period had maintained relatively steady lower amount. FGS is actively working with Advancement and Student Financial Services to better coordinate between all three units the promotion and disbursement of these awards and to increase funding opportunities for York graduate students. FGS has successfully been utilizing the monthly newsletters and social media channels to promote awards opportunities directly to students, in addition to communicating through graduate programs.

Other Major Doctoral Awards

FGS continues to play an active role in the nomination of outstanding students to Canada's most prestigious doctoral awards: the Vanier Canada Graduate Scholarship (\$50,000 for 3 years) and the Trudeau Foundation Scholarship (\$60,000 for up to 4 years). Annually, up to 167 Vanier CGS and 15 Trudeau Scholarships are offered across Canada.

The nomination process for Vanier and Trudeau competitions starts each summer with a call for nominations for the following academic year. In 2015-16 FGS received 160 applications, of which we put forward fourteen nominations (eight candidates for Vanier and six for Trudeau). All the nominees were assigned a senior faculty member to support the development of their final application package.

Scholarships for International Students

International students continue to be excluded from most internal and external awards due to the citizenship requirements of both federal/provincial funders and York donors. International students are encouraged to apply to the few that are available to them, including the Vanier and Trudeau scholarships, the Ontario Trillium Scholarships, Elia Scholars Program, and the Graduate Fellowships for Academic Distinction. International students are also encouraged to seek internal and external opportunities via the FGS site, the Student Financial Services awards search (http://sfs.yorku.ca/scholarships/award_search/index.htm) and the Government of Canada international awards database (http://www.scholarships-bourses.gc.ca/scholarships-bourses.gc.ca/scholarships-bourses/index.aspx?lang=eng). FGS continues to work with the Advancement office to seek new award opportunities for international students.

As is outlined in the University Academic Plan 2015-2020, the institution is committed to increasing the number of post-doctoral fellows and visitors on our campus and supporting their funding and research pursuits.

Looking Forward: 2017 and Beyond

Awards Management System: The Faculty of Graduate Studies, in collaboration with Student Financial Services and the Advancement office, is in the process of acquiring and implementing an awards management system which will facilitate the administration of awards, in particular, internal awards which are currently paper-based. The process has been tedious since FGS wishes to ensure that the final product in place meets all the requirements.

We expect that the awards management program will not only enhance student experiences but also significantly improve administrative efficiency for all stakeholders involved award management. Other Ontario universities that have recently implemented a similar system have reported a significant increase in the number of applications received while reducing administrative resources required for the adjudication.

1. Department of Political Science in the Faculty of Liberal Arts and Professional Studies: Change of Name to Department of Politics

APPRC recommends

that Senate approve a change in the name of the LA&PS Department of Political Science to the Department of Politics.

Rationale

This proposal has been approved by the LA&PS Faculty Council. It is supported by the Chair of the Department and colleagues, the Dean of the Faculty, and the Provost. The documentation includes a compelling rationale prepared by the Department. It should be noted that the names of constituent programs will not change as a result of the new Department name. APPRC enthusiastically endorses this proposal.

2. Senate Policy on Postdoctoral Researchers

APPRC recommends

that Senate approve a Senate Policy on Postdoctoral Researchers at York University as set out in Appendix B.

Rationale

For reasons described in the rationale, the Faculty of Graduate Studies took the lead in developing a first-ever Senate policy governing Postdoctoral Fellows and Postdoctoral Visitors at York. Unlike other research-intensive universities, York has not had such a policy and the FGS initiative aimed to address this lacuna. Having a policy will provide prospective and current postdoctoral researchers with greater certainty about the opportunities available to them and the protections afforded. It will also enhance the profile of postdoctoral research and affirm York's strong commitment to expanding the

number of incumbents.¹ For details on other aspects of the proposed Policy, please see the rationale provided by FGS. Documentation included the results of a thorough canvass of other universities' frameworks.

APPRC urges Senators to approve a policy that will help advance University Academic Plan and Strategic Research Plan goals.

3. Strategic Mandate 2 Discussion

Ontario universities are preparing submissions to the provincial government in the second round of Strategic Mandate Agreements. This SMA is of great importance to York and the draft document is one that should command the attention of Senators. Members of APPRC had an opportunity to review a draft at its meeting of April 20, and provided the Provost with a wide range of suggestions. For APPRC, a key touchstone in its own review of the SMA was the University Academic Plan. Members also took into account planning that is taking place throughout the University when the Committee offered suggestions on possible improvements to the text.

The Senate meeting affords Senators an opportunity to offer their own thoughts on the document and how it might be refined. As a guide to discussion on April 27, APPRC suggests that Senators focus on the following questions in the context of the UAP and other planning goals:

- Does the text reflect the vision and aspirations of York?
- Are the areas of differentiation Student Experience; Innovation in Teaching and Learning Excellence; Access and Equity; Research Excellence and Impact; and Innovation, Economic Development & Community Engagement –clearly demarcated and is the weight assigned to each area of differentiation appropriate?

¹ Please note that nothing in this policy prevents a postdoctoral researcher from <u>accepting</u> a faculty appointment prior to the completion of their postdoctoral. At York, fellows who choose to complete a postdoctoral assignment after accepting an appointment offer can opt for a leave of absence without pay from the hiring institution.

• How well do the proposed institutionally-defined metrics express and document York's strengths, distinctiveness and planning objectives?

The discussion will begin with a brief presentation on how the document took shape. APPRC hopes that many Senators will have an opportunity to respond to these questions and we encourage short, pointed interventions.

Documentation will be distributed.

4. Spotlight on the University Academic Plan 2015-2020: Priority 1. Innovative, Quality Programs for Academic Excellence

APPRC and Senate Executive have agreed that time should be set aside at meetings of Senate this year to highlight one of six priority areas of the University Academic Plan 2015-2020. The focus on the fourth in this series of discussions falls on Priority 1, Innovative, Quality Programs for Academic Excellence.

This is a pivotal section of the UAP. Recent discussions with the Deans, Principal and University Librarian turned, in part, on progress being made to pursue constituent goals and the extent to which quality drives innovation. APPRC is aware that progress is being made, but also that there is much that Senators, Senate itself and Senate committees can do to ensure that the objectives of Priority 1 stay at the forefront of planning.

The text of the section is reproduced below. Vice-Provost Academic Alice Pitt has agreed to help facilitate discussion with opening remarks and a presentation on initiatives underway. Because the UAP is Senate-approved and its objectives are clear, APPRC focused on a series of process questions in anticipation of the Senate meeting. The Committee welcomes Senators' views on the following:

- How can a sustained and constructive conversation be animated?
- How can APPRC, Senate and others promote an understanding of the UAP's imperatives?
- What else is required to advance UAP goals and other priorities, and will we be able to track progress?

UAP Text:

A paramount priority for the UAP 2015 – 2020 in advancing York's vision as a comprehensive, research-intensive and internationally recognized University is to enhance the quality of our academic programs. Program quality is notably among the top three factors that Ontario applicants weigh in deciding on the University they will attend. The Task Force Report on Academic Programs as well as our Cyclical Program Reviews, and student surveys identify a number of curricular innovations upon which to

Report to Senate (cont'd)

draw for enhancing innovation and quality including interdisciplinary content, research opportunities, and the clear articulation of learning outcomes. Maintaining the commitment to general education and the critical presence of liberal arts education throughout the curriculum will also ensure that our graduates acquire the transferable skills so critical to adapting to the new demands of citizenship and changing work settings.

York was an early adaptor to quality assurance processes, and has been in the vanguard as province-wide frameworks were developed. Most of our programs have well-developed learning outcomes and are moving to aligning their assessments to those outcomes. At the same time, cyclical program reviews have not fully addressed program challenges. The enrolment data provided for the institutional-wide review of all undergraduate and graduate programs revealed some pressing issues such as the high concentration of the University's undergraduate applications in 10 programs; overly complex degree requirements; program duplication; and programs experiencing long term declining enrolments.

Increasing comprehensiveness requires that we expand in the areas of health, engineering, science, business and professional programs, while also championing the liberal arts and other programs facing provincial declines in applications such as the creative arts. There are opportunities to offer students greater flexibility and career mobility with new and unique combinations between degree programs. New program proposals that are seeking approval by the Quality Council and the Ministry of Training, Colleges and Universities must be developed with in-depth knowledge of Senate's Policy on Quality Assurance, the University's Strategic Mandate Agreement with government, and a well-developed analysis of market needs and program distinctiveness. Approval of the program does not vouchsafe its viability and proposals must have credible enrolment targets and resource needs.

Senate has endorsed the Institutional Integrated Resource Plan and in doing so has signaled an appreciation of the necessity to consider, complete and implement action plans undertaken at the Faculty level aimed at enhancing the quality of our academic programs. These plans must address the challenges evident in the enrolment data, programs reviews, student surveys and other relevant sources of information.

In the next five years we will:

- 1. Develop and implement Faculty plans to enhance the quality of our academic programs (aligned to the extent possible with Cyclical Program Reviews)
 - 1.1. Faculty plans will seek opportunities to enhance innovative curriculum through interdisciplinary curriculum, research activities, cutting edge or distinct programming, etc.
 - 1.2. Faculty plans will address program challenges including overly complex degree requirements, program duplication and declining enrolments ensuring that

programs are coherently structured by investing, revising, consolidating or closing programs where appropriate

- 2. Strengthen our comprehensiveness and interdisciplinarity by:
 - 2.1. Developing innovative degree programs in business, education studies, engineering, health, professional studies and science that excel in curricular design and delivery, and align with societal needs as appropriate for our campuses
 - 2.2. Championing liberal and creative arts by seeking out opportunities to promote their value, enhancing program quality including innovative new degree combinations
 - 2.3. Achieving the optimal size and breadth in engineering leading to increased impact and reputation of engineering education
 - 2.4. Enhancing the flexibility and empowerment of students to pursue degree and other program combinations that allow them to pursue interests beyond their majors, collaborate, and/or enhance professional skills including an undergraduate "finishing year", as well as professional and course-based Masters programs
- 3. Ensure that the quality assurance framework is refined and respected including the submission of learning outcomes for every program and the alignment of assessment with learning outcomes
- 4. Create more Faculty-spanning curriculum (i.e., drawing on more than one academic unit) with incentives for cooperation

5. Concurrence with a Recommendation to Establish the Helen Aird Carswell Chair in Community Engaged Research in the Arts

At its meeting at Glendon College on April 20th, the Committee concurred with a recommendation made by the Provost to establish the Helen Aird Carswell Chair in Community Engaged Research in the Arts. The Chair will be housed in the School of the Arts, Media, Performance and Design and includes support for students.

In accordance with the Senate-Board *Policy on the Establishment and Designation of Research and Teaching Chairs, Professorships and Distinguished Fellowships,* the Committee is required to inform Senate of its decision and to convey confirmation to the Academic Resources Committee of the Board of Governors, which is responsible for recommending the formal establishment or renaming of chairs to the Board. 6. Reflections of Vice-President Brewer

APPRC is grateful to former Vice-President Finance and Administration Gary Brewer for taking time to meet with us on April 6th to reflect on the evolution of the budget context for academic planning during his time at York. As he did at Senate in March, he expressed gratitude to Senators and members of Senate's planning committee for their input in what he described as a 15-year conversation that helped connect him with the collegium and work toward an integrated approach to planning. A summary of his perspectives follows.

For Vice-President Brewer, the Institutional Integrated Resource Plan and SHARP represent the culmination of efforts to align budgets with academic priorities of the Faculties and Senate. An integrated approach permits Senate and colleagues throughout the University to better understand, focus on and contribute to key planning objectives. Moving away from an incremental budget model to one that is transparent, accountable and responsible was an important step, and the group that helped design SHARP included two members of APPRC. IRPs and the IIRP are explicitly tied to the University Academic Plan's objectives, and this, too, was a significant stride forward.

As the current and past UAPs have noted, planning tools are particularly valuable in a resource-constrained environment, and take on additional utility at a time when the government is pursuing a framework in which university identities take on greater importance and a premium is placed on how commitments are met. Over the years Vice-President Brewer was able to move from expressing planning goals in text only to citing numbers. Even so, he believes that SHARP is not about accounting so much as a tool to foster greater transparency, certainty, autonomy and responsibility. He stressed that SHARP has been deliberately developed to foster collaboration, and formulae have been developed to militate against competition while ensuring that funding is fairly attributed. Since SHARP is a Faculty-level instrument, decisions about the preservation of smaller or less well-resourced programs will rest with the Deans and Principal in consultation with the collegium; it is not intended to be punitive, but instead promote reflections on academic priorities and creative solutions to issues. The model will evolve with experience, and a review is planned, one that will necessarily address changing priorities and involve adjustments responsive to academic decision-making.

7. Monitoring the External Environment

This year the Committee has made a special effort to monitor the external environment and advise Senate when significant reports have been issued. Most recently the Committee reviewed summaries of the following research papers issued by the Higher Education Quality Council of Ontario:

Using Future Authoring to Improve Student Outcomes (Ross Finnie, Wayne Poirier, Eda Bozkurt, Jordan B. Peterson, Tim Fricker and Megan Pratt). The study found that

participants in a Future Authoring program originally piloted at Mohawk College had an overall leaving rate that was 3.3 to 4.3 percentage points lower than those in the control group. The effects were more pronounced for students who typically have higher leaving rates, including male students, those enrolled in certificate programs and interdisciplinary studies, and those with lower high school grades.

Labour Market Trends and Outlooks for Regulated Professions in Ontario (Prism Economics and Analysis). The study looked at the differences between the number of projected directly-related jobs and likely graduates in Law, Medicine, Nursing, Architecture and Engineering. The outlook for nursing graduates moving into related careers is good. It is uncertain for doctors. There are likely to be fewer jobs than graduates in other professions, although demand will be relatively strong for students with BEd degrees in certain subject areas.

What's the Story? National Media Coverage of Higher Education in Canada (Tanya Whyte, Kaspar Beelen, Alex Mierke-Zatwarnicki, Christopher Cochrane and Peter Loewen, University of Toronto, Scarborough.) This study found that media coverage of higher education has declined in the mainstream media in recent years. Government policy is the central topic covered in news articles. The number of news articles pertaining to skills and training increased over the time period under study, the only one of the eight topics to show an uptick and largely attributable to interest in occupations during and after the 2008-2009 recession. Tuition saw the most pronounced drop in coverage except for the period covering the Québec student strikes in 2012–2013, in which proposed tuition increases played a central role. Other matters drawing attention are scholarships and awards, plagiarism and legal issues, the societal and community role of postsecondary institutions, and campus safety and security.

I have reviewed the proposal from the Department of Political Science in the Faculty of Liberal Arts & Professional Studies to change its name to the Department of Politics, effective July 1, 2017. I am writing to record my support for this proposal. The proposal arises out of an academic planning process and follows extensive discussions within the department. Several reasons have been advanced for the proposed name change: it will more accurately reflect the academic interests, strengths, and approaches to the discipline of the department; it is intended to convey to students, in terminology that is clear to them, the range of issues that are dealt with in the department's programs, thereby attracting new students to those programs; and it will distinguish York's department of Political Science" is commonly used terminology at Canadian universities, "Department of Politics" is consistent with international terminology. It should be noted that only the name of the department would be changed as a result of this proposal; the titles of its degree programs would remain unchanged.

No new resources (faculty, staff, curriculum, etc.) are required to implement this proposal; and the Dean's Office has confirmed agreement with the proposed name change.

Proposal

The Department of Political Science is proposing to change its name to:

The Department of Politics.

We are writing to request the approval of APPC and for the proposal to be forwarded to Faculty Council and then to Senate for final approval.

Implementation Date

The proposed change in name will be effective 1 July 2017. Students and other members of the Departmental community will be notified by e-mail.

Rationale

There are two primary reasons for proposing this name change:

The first is in the interest of clearly defining for the outside community what • it is that is distinctive in the Department's approach to the study of politics. The York Department is unlike most, if not all, other Departments in Canada, and we seek a public representation which highlights our strengths and distinctiveness. The name is not the only part of such a representation. but it is and important marker. The name 'Political Science' has resonances that are associated with approaches to politics that not only are not strengths of this Department, but which most members of the Department actively contest in both their research and their teaching.

• The second is in the interest of attracting students to our programmes. It is increasingly clear that undergraduate students, in particular, do not know what 'Political Science' means, as they do not study it as a subject in High School. Therefore, while they may well be interested in the range of issues on which our degrees focus, they may also not look at us because they do not understand what we offer.

Taken together, these two goals suggest that a change in the name of the Department would be a useful contribution to our ongoing efforts at building our already excellent reputation, and attracting a large cohort of strong undergraduate applicants to our degrees.

If we look across the country, the 46 other leading English-speaking Departments in our field are overwhelmingly named Department of Political Science, with 30 of the 46 using this title. Of the remainder, four use Department of Political Studies, and the others have sui generis names. Only one, Acadia, presently uses Department of Politics and five combine Politics with something else (International Relations, International Studies, Philosophy, or Public Administration). Of the eleven Departments which we might consider our closest colleagues and competitors (see those highlighted in the list attached), none use Department of Politics, eight use Department of Political Science and two Department of Political Studies.

The change to the Department of Politics, therefore, has the following advantages:

- It marks us as clearly distinctive from our primary competitors at both the Undergraduate and Graduate levels;
- It indicates a difference in the scholarly identity of our Department and its programmes with the the resonances of the term 'Political Science';
- It states clearly, and in a fashion that students can better understand, what it is we do; and,
- It is a name we have already used in various forms (as for a number of years our public representation was 'Politics' with Department of Political Science in small type. Indeed, one of the first things visitors to the Department have seen for the past two decades is a Departmental sign with 'Politics' in large type.)

Process of Discussion and Decision

Clearly the decision to change the name of a unit that has stood for more than fifty years is not to be taken lightly, and it was not in this instance.

• Throughout 2015 the newly formed Departmental Planning Committee developed an Academic Plan for the Department, which was discussed in draft form on several occasions with the Department and was finally adopted in December of 2015. In that Plan, the consideration of a name change was identified as one of the steps towards the goals the Plan

outlined.

- At its meeting of 7 March 2016, the Departmental Council considered the proposal for a name change brought to the Council in the form of a notice of motion (a procedure that is rarely used at Council, but chosen to enable greater collegial consideration of the motion than the usual procedure of giving a week's notice with the circulation of an agenda). A discussion of the proposal was then held at the 7 March 2016 Council meeting. (Minutes attached)
- The motion was then brought to Department Council for a vote at its subsequent meeting (26 April 2016). Again a fulsome discussion was held, including considering a proposal from a member of Council to hold an electronic vote on the issue. Council decided not to hold an electronic vote, believing that the face-to-face discussion was an important part of a crucial collegial decision. In order to facilitate that discussion, Council passed a motion recommending that the name change be formally adopted at a special meeting of Department Council to be held at the time of the Departmental Retreat, planned for October 2016 (minutes attached). The reasoning was to provide a further six months for collegial discussion, knowing that the vote would be taken in October.

At the Departmental Retreat held on 27 October 2016, a Special Meeting of Department Council was convened to consider only the motion on the change of name. Following a further discussion, the motion to change the name to Department of Politics passed by a vote of 19-0, with 7 abstentions (minutes attached).

Senate Policy on Postdoctoral Researchers at York University

Policy Statement

Postdoctoral researchers are individuals professionally conducting research after the completion of their doctoral studies. As integral members of the York University research community, postdoctoral researchers make valuable contributions to their research fields, and are vital to the achievement of University Academic Plan objectives and other planning goals.

Scope and Definitions

This policy applies to postdoctoral fellows categorized as:

- a) Postdoctoral Visitors (PDVs) whose status is defined by the York University Faculty Association (YUFA) Collective Agreement
- b) Postdoctoral Fellows (PDFs) whose status is determined by an external award or funding source

Criteria for Positions and Appointments

The following criteria apply to these positions and the individuals who hold them:

- a) Positions
 - i) The fellowship shall be primarily research focused.
 - ii) The fellowship shall have a duration of no less than three (3) months.
 - iii) The fellowship shall be time limited at York University, normally up to three (3) years, and may not exceed four (4) years.
 - iv) Fellowships are intended to be full time. Exceptions may be permitted at the discretion of the Dean. All part-time fellowships shall offer the appointee a robust research and professional development opportunity. They are governed by, and shall adhere to, all aspects of this Policy.

b) Appointees

- i) Appointees must have completed all requirements for a PhD.
- ii) Appointees may not hold a full-time faculty member appointment at any university.
- iii) All appointees shall be supervised by a full-time faculty member at York.
- iv) The work of the appointee must meet the standards set by the supervisor and must comply with all relevant regulations, policies and procedures of York University.

Administration

- a) Administrative procedures for the engagement of post-doctoral researchers shall be set by the Faculty of Graduate Studies and implemented by all Faculties.
- b) The conduct of postdoctoral research is governed by University and Senate policies and procedures, including but not limited to the *Senate Policy on Responsible Conduct of Research*.

Dispute Resolution

In the event of a dispute between a postdoctoral researcher and any other member of the York University community, University policies, procedures and regulations apply. The Faculty of Graduate Studies shall

- a) maintain current information on supports and applicable processes for dispute resolution involving postdoctoral researchers
- b) respond to procedural inquiries and provide guidance upon request

Intellectual Property

An Intellectual Property Agreement between a postdoctoral researcher and supervisor that conforms to York University regulations on Intellectual Property shall be put in place before the start date of each fellowship. Deviations from standard Intellectual Property agreements shall be reviewed and approved by the Faculty of Graduate Studies and Vice-President Research & Innovation (VPRI).

Professional Development

Professional Development activities are central to the success of York University's postdoctoral researchers. It is expected that all appointees shall be encouraged to participate regularly in professional development programming and academic life across the campuses.

Rationale

Context/Background

York University is increasing its commitment to develop postdoctoral scholarship at its campuses. The University Academic Plans (UAP) and the Plan for the Intensification and Enhancement of Research (PIER), and the Integrated Institutional Resource Planning (IIRP) process, have each indicated the importance of expanding postdoc presence at York by increasing the number of postdocs and providing appropriate supports for this expansion. The responsibility for postdoc administration has been delegated to the Faculty of Graduate Studies (FGS) and the IIRP Working Group on the Future of Graduate Education has recommended changing the Faculty name to the Faculty of Graduate and Postdoctoral Studies.

With this expansion recognizing the importance of postdoctoral scholarship as integral to the research mission of the university, it is important to have a Policy approved by the Senate, the highest academic governance body at the University. Policy at the Senate level creates a shared understanding of the value of postdocs at the university, as well as the university's obligation to postdoctoral scholars as part of our research community. National conversations on postdoc issues (e.g., Canadian Association of Postdoctoral Administrators (CAPA) and Canadian Association of Postdoctoral Scholars (CAPS)) indicate the importance of a strong policy framework if York is to be positioned as a desired destination for national and international postdoctoral scholars. Notably, other research-intensive universities (see below) have policy at the Senate (or VP) level.

At York, there are two groups of postdoctoral scholars:

- a) Postdoctoral Visitors (PDVs) whose terms are defined by the York University Faculty Association (YUFA) Collective Agreement
- b) Postdoctoral Fellows (PDFs) whose status as a postdoc is determined by an external award or funding source

The PVF/PDV separation means we have some documents that govern some postdocs and not others. For this reason, we need a comprehensive set of supportive guidelines that will facilitate successful postdocs at York.

The proposed Policy takes into consideration the following:

- PDF / PDV distinction
- YUFA Collective Agreement (PDV only)
- Multiple and different academic disciplinary cultures (e.g., postdocs working in science labs, SSRHC-funded postdocs doing field work, etc.)
- Tri-Council and other funder rules
- Other Senate Policies
- Research on the postdoctoral scholarship policies of 32 Canadian universities

National Research

The Faculty of Graduate Studies conducted research on:

- Which universities have policy on postdoctoral scholars
- Location of policy (Senate, VP, Faculty levels, or equivalent/other)
- Commons clauses included within comparable policies

32 University policies and guidelines on postdocs were reviewed in all (see attached – Appendix A). Research findings include:

- 13 universities have policy approved by Senate, including large, research intensive universities such as University of Alberta, the University of British Columbia, McMaster University and the University of Toronto.
- 9 more universities have policy approved by a VP or Provost
- Most common clauses include those listed below:

Consultation Process

An extensive consultation process was undertaken between summer 2016 and February 2017. York University faculty, postdocs, and research administrators were asked to comment on whether or York University would benefit from a Senate policy on postdocs. While there were differing opinions about which clauses a policy should include, there was overwhelming consensus among faculty, postdocs and research staff that York requires a strong set of general principles to support all postdoctoral scholars on campus. York research community members were also asked to comment on draft policy documents in person and on-line. A detailed consultation schedule is below:

The consultations process led to several revisions to the initial drafts and confirmed that:

- It is essential to have a policy that allows postdocs the option of teaching if appropriate under their contract, and encourages other forms of professional development.
- York policy should not include a limit on the number of years that a post-PhD candidate should be able to take up a postdoctoral fellowship or visitorship. This limitation, which is present in other policies, was seen to be insensitive to diverse career paths and the need to retrain throughout one's career. Moreover, CIHR recently changed its policy to remove limits on eligibility based on the number of years after a PhD is granted (removing a previous 5-year limit). York Senate Policy should not contradict Tri-Council policies.
- Additional feedback included a call many requests to address topics that are operational (e.g., allocation of lab space, provision of business cards, etc.) or covered by collective agreements (e.g., minimum salary, benefit packages, etc.). These topics were excluded from policy.

I am writing to seek the concurrence of APPRC for the establishment of an endowed chair in the School of the Arts, Media, Performance and Design: the Helen Aird Carswell Endowed Chair in Community Engaged Research in the Arts (CERA). The chair will be funded by an endowment from the Carswell Family Foundation (founded by Allan Carswell, York faculty member emeritus in the Faculty of Science, and his wife Helen, both passionate advocates of supporting access to the arts for high-risk, socio-economically disadvantaged youth), supplemented by matching funds allocated by York University.

The establishment of this chair is consistent with AMPD's vision of preparing next generation artists, designers, performers and scholars, who not only achieve artistic virtuosity related to their creative disciplines, but who also have a deep appreciation for the cultural and societal issues we face, and are uniquely equipped to provide engaged leadership across diverse communities. It also aligns with York's commitment to community engagement. In traditional endowed Chair positions, the funding is primarily to the chair holder's own research. This proposed chair provides resources to support the chair, recruit graduate students to York who are working in community engaged research in the arts, provide funds for internal research awards to York faculty who are engaged with research that makes unique contributions to academic and scientific literature, and support an environment that positively impacts childhood success through access to the arts. The CERA Chair is unique in that it brings together a number of research areas and individuals that can make contributions to the body of research concerned with the link between arts programs, early childhood education and community development.

The chair will generally be a three-year rotating position held in AMPD. The chairholder will be a faculty member in AMPD or in another York Faculty with an existing affiliation with AMPD. The chair is selected through a nomination process that is managed by the CERA Executive Board which is chaired by the Dean of AMPD. While the individual research direction of the Carswell Chair is flexible and will shift with the holder, each holder will orient the focus of the program primarily towards how access to the arts can positively impact children's education and learning.

Office of the Vice-President Academic and Provost

How can we improve and provide arts education to children differently? What are the beneficial and measurable impacts of different kinds of artistic programming on children's well-being, performance, school attainment and health, etc.? The Carswell Chair is also expected to attract external partnership and industrial research funding and enhance York's international reputation.

The York University Policy on Endowed Chairs and Professorships indicates that in such situations as this, where the proposed Chair/Professorship is consistent with an existing Senate-approved teaching program and where the other terms and conditions set out in the policy are met, the Vice-President Academic & Provost may ask for the concurrence of APPRC so that the Board of Governors might consider the proposal. By this memorandum, I confirm that the proposed Chair satisfies the expectations of the University policy, and unless APPRC has questions regarding it, I ask that this matter be placed on the agenda of the Board of Governors for consideration at its next meeting.

8. Academic Policy, Planning and Research

a. Markham Centre Campus Planning: Update

APPRC advised that Provost Lenton had briefed the Committee on Markham Campus planning developments and it shared with Senators a presentation that accompanied her report. The Committee noted that academic program planning is proceeding on a collegial basis, and that the opportunities presented by the new campus have generated enthusiasm and creative engagement.

> b. Spotlight on the University Academic Plan 2015-2020: Priority 5. Enhanced Campus Experience

The third in a series of spotlight discussions on priority areas was devoted the section on Priority 5: Enhanced Campus Experience. Vice-President Brewer opened discussion with a brief presentation on goals and initiatives. Among the comments were the following:

- an ongoing issue for the community is the availability of wholesome food options on all campuses; a full-service grocery store has been sought and the York University Development Corporation is mindful of community desires as it pursues options
- funds for the building and renovation of campus facilities are provided for in the University's capital budget, and are also facilitated by special government grants
- the new Quad residence is not so much luxurious as in keeping with contemporary tastes and students' express preferences; all other residences will be renewed according to an upgrading plan that will see improvements to the housing stock on the campuses
- linkages with the Sustainability Council are highly desirable, and members of the community are encouraged to attend sessions on campus planning and sustainability

In response to a number of expressions of gratitude, Vice-President Brewer thanked APPRC and Senate for their input over the years, especially with regard to the alignment of budgets and academic priorities. He will encourage his successor to take every opportunity for enrichment in academic governance settings.

c. Meetings with the Deans, Principal and University Librarian

APPRC reported that it was nearing the conclusion of its meetings with the Deans, Principal and University Librarian and expects to report on the discussions this spring.
