Synopsis of the 582nd Meeting of Senate March 22, 2012

Remarks

The Chair of Senate, Professor William van Wijngaarden

- confirmed receipt of two motions concerning the York-Centre for International Governance Innovation collaborative initiative; these motions, which were transmitted to the Chair after the meeting agenda had been distributed, were referred to the Executive Committee in order to coordinate their consideration and clarify their meaning and status
- confirmed that documents forwarded by the Osgoode Hall Faculty Council concerning York-CIGI had been posted on the Senate Website, and acknowledged receipt of an open letter from some full-time faculty members on the same matter
- responded to an inquiry about the teaching evaluation audit being conducted by the Auditor General of Ontario

President Shoukri

- confirmed that the Ontario government's current tuition fee framework (of up to 5 per cent increases) would continue for another year, and that the fee rebate program had been unchanged
- commented on the public policy context for postsecondary education in Ontario
- described the University's campaign to encourage enrolments in an expanded summer program
- saluted notable accomplishments by members of the University community, and reminded Senators that the University's fifty-third anniversary would be celebrated on March 26
- referred Senators to a Website listing recipients of honorary degrees at the Spring Convocations

Vice-President Academic and Provost Patrick Monahan

- assured Senate that all faculty workshops and teaching assistant practica scheduled by the Centre for the Support of Teaching for the year had been completed despite its closure
- briefed Senate on the terms of a proposed collaboration between the University and CIGI in the area of
 international law; responded to concerns about academic freedom, University autonomy and
 appointments processes; and reported that APPRC had agreed to work with him in the development of
 an academic governance framework for the collaboration that would be presented to Senate for
 approval in April

submitted a synopsis of the February meeting of the Board of Governors

provided Senate with the most recent COU issues summary
