There is a deep disconnect between the Board of Governors and the substantive representation of the York University community interest writ large. The choices made by Board of Governors impact students, faculty members, and workers alike, yet these various stakeholders are not meaningfully consulted or represented in the Board's decision-making processes. My primary motivation for running for the Board's graduate student representative position is to challenge the Board's current prioritization of private and corporate interests by advocating for those issues most important to York's broader community.

As a student representative, I would take up an agenda to address both the symbolic and material shortcomings of the Board's composition and determinations. This includes bringing more a diverse membership to the Board, advancing the goals of student-led campaigns like Fossil Free York and YorkU Divest, attending to the dilapidated building and infrastructure on campus, moving towards improved public transit on campus and a system-wide integrated fare, and resisting the recent changes to Ontario post-secondary education policy by the provincial government.
