



2016-2017 YORK UNIVERSITY PRESIDENT'S EMERGING RESEARCH LEADERSHIP AWARD

The York University President's Emerging Research Leadership Award recognizes full-time faculty members within 10 years of their first academic appointment, who have had a notable impact on their field(s) and made a significant contribution to advancing the University's international reputation for research excellence while significantly and positively contributing to one or more aspects of the York community's intellectual life.

AWARD VALUE

\$5000 internal research grant deposited to the recipient's generic research cost centre.

ELIGIBILITY

- This award is inclusive of all individuals with tenure-stream appointments at York who are between five and 10 years of their first academic appointment.
- This honour demands outstanding emerging research achievement providing the promise of long term leadership in their field.
- At least five years of that research must have been completed while the nominee held a faculty appointment at York.
- Faculty members on the adjudication committee are not eligible for nomination. Should a member of the Senate Committee on Awards be nominated for this award, s/he must step down from the Committee.

NOMINATION CRITERIA

The nominee's achievements must be documented to demonstrate his or her fulfillment of the following general requirements:

- The research should include contributions to the nominee's field(s) of scholarship at a high level.
- The research should hold the promise of major impact on the related discipline or field of study and/or practice.
- The nominee should be developing an international reputation for research excellence and have made a significant contribution to the University's research culture and reputation.

Research achievement will have included peer assessment and will have entailed publication or other internationally-recognized and accepted demonstrations of authoritative scholarship or creative contribution.

Nominees must have demonstrated their leadership not only as outstanding emerging researchers, but also as notable contributors to York's intellectual community. Examples may include, but are not limited to:

- mentoring students, postdoctoral fellows and contributing critical input in the assistance of colleagues
- On a pathway towards leadership of collaborative research programs or research centres
- attracting talented graduate students or postdoctoral fellows to York
- building linkages with other institutions, such as universities, colleges or on-government organizations and/or engaging in entrepreneurial activities.
- securing significant external research funding for York
- making York a more innovative research institution

NOMINATION PROCESS

A complete nomination includes a nomination form, letter of nomination, nominee's current curriculum vitae, confidential letters of support (max. 5, at least two from within the York community) and a letter from the nominee (max. 1,000 words). See below for more information on each component of the file. The nominator must submit the nomination file to the [Secretary, Senate Committee on Awards](#), University Secretariat, 1050 Kaneff Tower, no later than Friday, November 25, 2016 at 4:30 p.m.

PLEASE NOTE: The Committee shall, in confidence, provide a complete copy of the file to the Dean of the nominee's home Faculty and shall invite the Dean to provide a confidential letter of commentary on the nomination.

NOMINATION FILE REQUIRED DOCUMENTS

Complete files must be submitted either entirely by hardcopy or electronically.

Hardcopy Files: Submit hardcopy files on plain white paper, without covers and paper-clipped in the upper-left-hand corner. Do not staple. Please ensure that the letters from the nominator and nominee have original signatures.

Electronic Files: The nominator should submit all documents electronically to [Terry Carter](#). Please ensure that the letters from the nominator and nominee have electronic signatures.

- **Nomination Form (Page 3 below)**
- **Nominator's Letter** – The nominator's letter must explain how the nominee meets the award's criteria. It will serve as the core of each nomination file. It should outline:
 - themes and evolution of the nominee's sustained research contributions
 - the impact said contributions have made to his or her field(s) of study and discipline
 - contributions the nominee has made to furthering York's intellectual life major scholarly, professional and/or artistic accomplishments
 - evidence of national and international recognition and reputation

- **Nominee's Current Curriculum Vitae**
- **Confidential Letters of Support** - A maximum of five letters of support, at least two of which must be from individuals within the York University community.
- **Letter from Nominee** - The nominee's acknowledgement of the award nomination, which should reflect on those aspects of her or his career that most concretely demonstrate the award's criteria (maximum 1,000 words).

To ensure equal consideration and treatment of all nominees, additional documentation or documentation over the specified word limit for the letter from the nominee will not be considered.

ADJUDICATION AND ANNOUNCEMENT OF AWARD

The Award will be adjudicated by the Senate Committee on Awards and presented by the President at a celebration in Spring 2017.
