
#### YORK'S CAMPUSES

York's main campuses are located in the heart of the Greater Toronto Area, Canada's largest metropolis. They include:

- Keele Campus, spanning 457 acres at 4700 Keele St., is home to five libraries, 92 buildings, athletic facilities, theatres, galleries, residences, a shopping mall and a variety of green spaces;
- Glendon Campus, located in a park-like setting at 2275 Bayview Ave., offers a fully bilingual environment to its 2,700 students; and
- A third campus, to be built in Markham Centre, will accommodate up to 10,000 students. York also has an MBA campus in Hyderabad, India and an EcoCampus in Las Nubes, Costa Rica.

#### THE YORK COMMUNITY

York University is a vibrant, richly diverse community of 46,400+ undergraduate students, 5,900+ graduate students, 7,000+ faculty and staff and 295,000+ alumni in over 170 countries. The York community is a global microcosm that celebrates diversity and is respectful of difference, whether in terms of personal characteristics such as race, religion, gender, gender identity and ability or in terms of social and political views. York is a progressive university that actively promotes diversity and inclusion, social justice and equity and initiatives supporting environmental, social and fiscal sustainability.

#### INNOVATIVE PROGRAMS

- York has achieved top national and international rankings in pre-eminent programs in business, humanities, law and social sciences offered through its Faculties of Liberal Arts & Professional Studies, Osgoode Hall Law School and the Schulich School of Business.
- The University has become more comprehensive with the creation of the Lassonde School of Engineering and new undergraduate and graduate programs in business, education studies, engineering and global health.
- The launch of the School of the Arts, Media, Performance & Design reflects expanded capacity for arts innovation, while enriching existing strengths.
- The profile of the Faculty of Science has risen thanks to high-impact research and curricular innovations, as well as extensive public outreach and media engagement.
- Having established the first environmental studies program in Canada in 1968, the Faculty
  of Environmental Studies now offers innovative undergraduate, master's and doctoral programs.
  In 2016, the Faculty opened the Lillian Meighen Wright Centre, the landmark building of York's
  25-acre EcoCampus in Las Nubes, Costa Rica.
- Glendon has furthered the role it plays as a bilingual hub, serving the needs of central and southwestern Ontario for expanded francophone programming.
- York University's graduate students form the largest group of active researchers and scholars in the University, studying within an impressive array of traditional and interdisciplinary programs. These programs have strengthened York's reputation in leading-edge interdisciplinary curriculum and inspired new collaborations.

York has established a worldwide reputation. It has formed partnerships with over 200 international universities and has attracted students with roots in over 170 countries. York University's worldwide research partnerships, international perspective and commitment to social justice are making a profound global contribution.

### **LIBRARIES**

The four branches of York University Libraries are host to over three million visitors annually, providing access to a robust collection of resources, including more than 600,000 e-books, 72,000 full-text e-journals and 2.6 million printed volumes. Students have access to more than 3,600 quiet and collaborative study spaces. York University's 150 library staff members support the entire life cycle of scholarship and are recognized for their expertise in 21st-century librarianship.



#### STUDENT LIFE

With more than 300 student clubs and organizations, the intellectual, cultural and social offerings at York are among the richest in Canada. York University Sport & Recreation offers intramurals, a fitness centre, sports clubs, instructional classes and more. In 2015, the York University Lions won two championship banners: the Canadian Interuniversity Sport (CIS) and Ontario University Athletics (OUA) men's soccer titles.

Investments in the York University community include new residence units (now totalling 4,047), a new 150,000 sq. ft. student centre (currently being constructed), and on-campus subway stations scheduled to open in 2017.

York University's Health Education & Promotion team focuses on creating a community that supports student well-being across a range of areas, including mental health and stress management, nutrition and sexual health. In addition, York University's Mental Health & Wellness Committee aims to promote a healthy, inclusive and supportive environment for members of the York community. Counselling & Disability Services provides a professional and supportive environment in which all York students have



equal access to a range of services that assist in facilitating their academic success. York Security Services is committed to keeping the University's campuses safe for everyone.

Students have access to a wide array of cultural and entertainment options to enhance their academic experience. Hundreds of student-run events and on-campus theatre productions take place on York's campuses each year. York offers a college system that provides students with a place to study, hang out and get involved in a smaller, more intimate setting.

# ROLE OF THE PRESIDENT AND VICE-CHANCELLOR

York University operates under a bicameral system in which the President and Vice-Chancellor reports to the Board of Governors and works with the University Senate. The President advances and communicates the University's vision to ensure focused pursuit of its mission, and champions its commitment to achieving new levels of excellence as a leading global university.

As Vice-Chancellor and Chief Executive Officer of the University, the President leads the University community in realizing its teaching, research, service and learning goals. The President is responsible for leading or supporting others in collegially developing and implementing the University's strategic, academic, research and operational plans, priorities and policies.

The President and Vice-Chancellor ensures that the University upholds and reflects the principles of academic freedom, human rights, institutional autonomy and collegial governance. Responsible for ensuring that the University is a welcoming, inclusive and safe environment in which to learn, live and work, the President sets the tone for the University's culture, fostering a climate of positive, respectful, collegial relations among all members of the University. The President also leads the University in engaging positively and productively with the communities surrounding its campuses.

Chief ambassador and spokesperson for York University, the President and Vice-Chancellor builds and maintains relationships with diverse stakeholders, including governments, granting councils, alumni, donors and partners, whether local, national or international. The President advances the University's interests, seeking opportunities and raising funds to support its plans and aspirations. The President also works with other post-secondary leaders to advocate for York University and on behalf of post-secondary education generally.



**Challenges, opportunities and priorities** that emerged from the Presidential Search Consultations include the following:

- York University's eighth President and Vice-Chancellor will advance and evolve a vision and strategic
  plan that celebrate York University's core strengths. Building collaboratively on existing goals and
  directions, the President will champion a vision for York that promotes its continuing development
  as a university with a rich diversity of programs and intensifying research activity. Aspirational, clear,
  achievable and sustainable, this vision will unify, inspire and guide this great university into its next stage
  of national and international eminence.
- The next President will champion the University's academic and research goals with an innovative spirit and a profound sense of community, inspiring a commitment to lifelong learning, equity and societal engagement. A natural collaborator, the next President will enrich the spirit of co-operation and inclusivity that has attracted diverse students, faculty and staff to York University for more than half a century.
- The next President will continue to strengthen York University's distinctive profile and record in local, national and international arenas by supporting and promoting faculty and student achievement.
- The next President will be a positive, resilient and successful advocate for York University's interests with government officials and other key stakeholders.
- The next President will be conversant with the Ontario context its rapidly changing demographics, expectations and budgets. While continuing to support teaching, learning, research and service of the highest quality, the President will work collegially with administrators, faculties, schools, departments and colleges across campuses to find opportunities and to promote new paradigms of program delivery and interdisciplinary enterprise.
- The next President will work to improve outcomes for students and to strengthen the social contract between the University and all its students, reinforcing fundamental notions of respect, inclusivity and diligence by all concerned, fostering pride in achievement and promoting the development of informed and engaged citizens.



- The next President will successfully complete current initiatives such as the University's \$500 million Impact campaign and the building of the Markham campus, while also planning for and responding to challenges (such as enrolment patterns) and imminent changes (e.g. subway access).
- The next President will facilitate positive and respectful labour relations.
- The next President will foster collegial governance relations with and among Senate and the Board of Governors.
- The next President will cultivate relationships of trust with, between and amongst students, faculty, staff and administration, and across the broader network of alumni, York's community neighbours, industry, government, peer and partner organizations and public, corporate and individual funders.
- The next President will recognize and celebrate accomplishments in teaching, learning, research and service. To sustain and augment York University's successes, the President will enhance talent attraction, succession planning and professional development practices that enable trusted academic, administrative and staff leadership.
- The next President will advance and support institutional integrated resource planning, including efforts to develop a more responsive administrative infrastructure with effective support services and optimal use of resources. The President will ensure that York University's learning, working, research and public spaces are maintained and enhanced, promoting pride of place and a welcoming environment, and that strategic priorities are better secured through identification of new revenue sources, innovative delivery opportunities and high-quality investments.



# MEMBERS OF THE PRESIDENTIAL SEARCH COMMITTEE

**Rick Waugh** (governor and alumnus) is chair of the Search Committee. He was appointed to the Board of Governors in 2014 and became chair in 2015. He holds a bachelor of commerce (honours) degree from the University of Manitoba, an MBA from York and honorary doctor of laws degrees from several universities. He was appointed an officer of the Order of Canada for his contributions to strengthening the financial services industry in Canada and abroad.

**Ozench Ibrahim** (governor) was appointed to the Board of Governors on July 1, 2009, and serves as chair of the Finance & Audit Committee and as a member of the Executive Committee. She is a partner in KPMG's Banking, Financial Institutions practice. She has extensive experience in the financial institutions industry, auditing and advising Canadian banks.

**Ray Jayawardhana** (Science) is the dean of the Faculty of Science, a position he has held since 2014. He is a professor of physics and astronomy, and also a popular science writer. He came to York from the University of Toronto, where he held the Canada Research Chair in Observational Astrophysics.

**Michael Kenny** (graduate student, Education) is a second-year PhD student in the Faculty of Education. He was a member of the last decanal Search Committee in the Faculty of Environmental Studies and has served on several boards of agencies, including the Escarpment Biosphere Conservancy and Regenesis at York University.

**David Leyton-Brown** (LA&PS) is the master of McLaughlin College, a professor of political science and the former dean of the Faculty of Graduate Studies. He also recently served as a faculty member representative on the Board of Governors and participated on the Academic Resources Committee.

**David McFadden** (governor and alumnus) was appointed to the Board of Governors in 2013 and serves as chair of the Governance & Human Resource Committee and as a member of the Executive Committee. He is counsel at Gowling Lafleur Henderson LLP and is the chair of the Board of Directors of 407 International Inc.

**Kim Michasiw** (LA&PS) is an associate professor of English/writing and is completing a lengthy term as associate dean in the Faculty of Liberal Arts & Professional Studies. He is also a former chair of the Department of English. He served on the last Presidential Search Committee.

**Roxanne Mykitiuk** (Osgoode) is an associate professor of law. She is the former chair of Senate and has served on numerous Senate and Faculty committees, the Chancellor Search Committee and many pan-University groups.

**Dalubuhle Ndlovu** (undergraduate student, LA&PS) is in his third year in the Human Rights & Equity Studies program. He is a senator, the executive treasurer of the Student Council of the Faculty of Liberal Arts & Professional Studies, and a member of the LA&PS Faculty Council and its Executive Committee.

He holds both a bachelor's and a master's degrees in electrical engineering and computer science from MIT.
